IN ADDITION TO INDIVIDUAL THERAPY, SUPPORT AND EDUCATION IS ALSO PROVIDED FOR THE FAMILIES OF THE ENROLLED CHILD. THE SERVICES ARE OFFERED TO ALL RESIDENTS OF THE NORTHEAST DALLAS GEOGRAPHIC REGION.
